Medicare MBI Numbers


Starting January 1st, 2020, the MBI number is required for all Medicare claim submissions. Some features have been added to eTHOMAS that will allow the office to more easily identify the patients who do not have the updated numbers in their policy.

Posting Validations

Posting Validations can be created to warn the user if the contract number is not a certain number of characters. Since all MBI numbers are 11 characters, a valdation can be set up to warn you if the patient's financial code is MR and the contract number is not 11 characters in length. This can be customized to your office to use any financial or insurance codes you want.

When posting charges on a patient with the scenario in the Posting Validation, a pop-up message will alert you that the patient does not have the new MBI number in eTHOMAS.



Prebilling Report

When billing a Medicare claim, if the contract number is not 11 characters, eTHOMAS will warn you on the prebilling report that the contract number doesn't appear to be right. This is only a warning and the claim can still be sent to the insurance company, but we advise that these messages are taken seriously as failure to submit Medicare claims with the MBI number after January 01, 2020 may result in claim rejections.
